Rules Applying to Dog Shows
Effective January1, 2010

Chapter 11, Section 1

No dog shall be exhibited in a licensed or member dog show, except for dogs entered in the Miscellaneous Class, unless it is either individually registered in the AKC Stud Book, or individually registered with a foreign registry organization whose pedigrees are acceptable for AKC registration.

Directions to hotel

From the South: Take the FL turnpike to exit 242 making a left turn onto US Hwy 192. Hotel will be two miles on the right.

From the North: Take the FL turnpike to exit 244 making a right turn onto US Hwy 192. Remain in the far right lane. The hotel will be on the right.

From the Airport: Take South exit for Boggy Creek Rd. Make a right at intersection of Boggy Creek Rd. Continue on Boggy Creek Rd until it turns into Simpson Rd. (when Boggy Creek Rd. turns right). Follow Simpson Rd to US Hwy 192. Make a left turn onto US Hwy 192. At the next light make a U turn. The hotel will be on the right.

From the West: Take US Hwy 192 East until you reach Kissimmee/St.Cloud. U turn at the entrance to the turnpike. The hotel will be on your right.

Please note: The main highway has 4 different names: Irlo Bronson Memorial Hwy, Hwy 192, Vine Street (in Kissimmee), and 13th Street (in Saint Cloud). The Turnpike is also know as Ronald Reagan Parkway, or the Sunshine Pkwy.

Notice to dog owners/exhibitors :

When you sign the show entry form, you automatically agree to the following terms concerning motels. They have been established for the good of all exhibitors and will ensure future use of these facilities.

Rules at the Host Hotels:

1. Maximum 4 dogs per room
2. **Plastic sheeting must be placed under all crates in hotel rooms.**
3. Dogs left unattended in room must be crated with the plastic sheeting under crates
4. Housekeeping must be allowed to clean a guest room (with dogs) at least every two days. Guests who have special request (i.e. a certain time of day that room will be vacant) can discuss them with the housekeeping staff upon arrival.
5. Bathing and/or grooming of dogs in or right outside the guest rooms is NOT allowed. The hotel will impose a \$100.00 penalty to anyone found grooming in this manner. There will be bathing facilities at the show site. Grooming is not allowed on any sidewalks.
6. Owner/exhibitors should bring their own toweling for bathing dogs. A daily inventory for missing or damaged towels will be taken and any necessary charges will be applied to guests.
7. Dogs must be kept on a leash at all times while out of the guest room.
8. Dogs should be exercised in designated areas on the hotel premises. Every dog owner is expected to pick up after their own dog and dispose of waste in designated receptacles. It is the responsibility of the dog owners to find out from the motel staff where these areas and receptacles are located.
9. No exercise pens permitted in grass areas of hotels
10. The hotel and the show committee will investigate any problem areas that are outlined above. Any guest not following the above guidelines will be asked to check out of the hotel without refund. The Show committee will make a report to the AKC
11. Rooms will be inspected daily by members of the motel staff and observed violations or damages will be reported to the hotel management and/or the show committee.
The show committee, working with a fair and equitable system, is charged with investigating complaints. Each dog owner/exhibitor is expected to cooperate with the investigative committee if a complaint is filed.
12. Flash photography is not permitted ringside.
13. Cell phones must be turned off or on vibrate at ringsides. Please leave area to use cell phone.
14. No smoking indoors or within 25 feet of any performance trial ring or doors.

NOTICE TO EXHIBITORS



The AKC will collect a \$3.00 AKC Recording Fee for each entry of a dog in all AKC licensed and member dog shows, obedience trials, and tracking tests. If a dog is entered in more than one class in the show, the Event/Recording Fees will be collected on each entry.

- **Please note: Rally is considered a separate trial from obedience.**
- At every licensed or member club Rally Trial, a Recording Fee of \$3.50 shall be required for the entry of each dog. (AKC Rally Regulations, Chapter 1, Section 3).
- A show-giving club shall assume the responsibility of collecting all Recording Fees and Event Service Fees for the AKC.
- **Canadian Exhibitors must submit entries with checks drawn on U.S. Accounts or with international money orders in U.S. funds.**
- Dogs need be present only for scheduled judging and will be released if not needed for further judging.
- Dogs must be ready for judging. Neither the club nor its Superintendent will be responsible or obligated to furnish any service for notifying exhibitors or agents of Class Judging. Judges need not wait for any dog holding up a class. Owners or agents alone are responsible for the presence of dogs in the judging rings.
- No Entry will be accepted which specifies any condition as to its acceptance. Telegraph, E-mail and unsigned entries cannot be accepted and will be returned. Entries not on Official AKC Entry Forms and Photocopies of Entry Forms without the Agreement and Rules on the reverse side are NOT ACCEPTABLE. The club and/or its Superintendent assumes no responsibility for wrong or incomplete information given on the entry blank by the owner or the owner's agent. **Responsibility for completeness of any entry rests solely with entrant.**
- Entry fees shall NOT be refunded in the event that a dog is absent, disqualified, sick, lame, excused by the Judge or Veterinarian, or barred from competition by action of the Show Committee, or because it has been entered incorrectly. There is no refund or entry fee for bitches in season. There is no refund for duplicate entries or overpayments. The Superintendent/Secretary will make every effort to find all duplicate entries, but if entry has been processed, no refund will be made. If, because of riots, civil disturbances or other acts beyond the control of the management it is impossible to open, or to complete the show, NO REFUND will be made.
- **Returned checks do not constitute a valid entry fee.** The Superintendent/Secretary will add a \$20.00 collection fee to the amount of each returned check.
- **Refunds** for cancellations due to judge change or cancellation made prior to entries closing will be mailed to said exhibitor or agent after the show.
- **Entries will be acknowledged** after entries close with entry acknowledgement and judging program to address on entry. Should Exhibitor NOT receive an acknowledgement within a reasonable time, PLEASE notify the Secretary at (360) 681-5055 or E-mail: heelin@earthlink.net.
- **Loss or Damage:** The Show Committee will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume any liability in the event of any accident or misfortune to either dogs or exhibitors participating in these shows. The welfare of an Exhibitor's child is assumed to be the responsibility of the Exhibitor. It is distinctly understood that Exhibitors will exercise control and restraint over their children on the day of the show.

Best All Around Sheltie

To be eligible for this award, dogs must compete in **four of five** events. *Advance registration is required.* Registrations should be mailed after you have officially entered at least four events.

Point values will be assigned to entrants in competition as follows:

Breed

- 1 pt.—participation
- 2 pt.—make a cut
- 3 pt.—place 1-4 in a class
- 4 pt.—RW, Winners, BOB, BOS, AOM, Select

Rally

- 1 pt. – Participation
- 2 pt. – Qualifying Novice Score
- 3 pt. – Qualifying Advanced Score
- 4 pt. – Qualifying Excellent Score

Herding

- 1 pt.—Participation
- 2 pt.—Herding Tested/Pre Trial Tested
- 3 pt.—Qualifying Started/Intermediate Score
- 4 pt.—Qualifying Advanced Score

Obedience

- 1 pt.—participation
- 2 pt.— Qualifying Novice Score
- 3 pt.—Qualifying Open Score
- 4 pt.— Qualifying Utility Score

Agility

- 1 pt. – Participation
- 2 pt. – Qualifying Novice Score
- 3 pt. – Qualifying Open Score
- 4 pt. – Qualifying Excellent Score

BONUS 1 pt for a dog who competes in all five venues

Dogs receiving qualifying scores in performance events will be awarded 2, 3, or 4 points as appropriate for their class, but do not receive the participation point as well. The participation point in performance events is awarded only if the dog competes but does not qualify in the event. Dogs competing in multiple classes at the same event will be credited with the highest placement received in any one class only.

Dogs who make a cut or earn placements and awards in breed competition will be awarded 2, 3, or 4 points as applicable to the award, but do not receive the participation point as well. Dogs who make multiple cuts in a class will receive the same 2 points as dogs who make one cut. Dogs excused from the breed ring shall still be awarded a point for participation. Dogs disqualified from the breed ring shall not be awarded a point for participation. In the event of a tie, event scores shall be used to break the tie. The dog with the highest total score will receive the award.

The official catalog markings taken from the judges' books for each event shall be used to determine eligibility, participation, placements and official scores.
