Dear All,

An urgent meeting of the Executive Committee of Karnataka State Parivaar Federation [KSPF] was held on Wednesday, the 10th Feb. 2016 to review its earlier decision to hold a rally on 23rd Feb. 2016 of parents, PwDs activists and NGO representatives working in disability sector demanding passing of RPD Bill in the Budget session of Parliament.

The meeting took note of the recent developments in the sector, some of them positive ones, like the appointment of a new Secretary of the Dept. of Empowerment of the PwDs, appointment of a new Chief Commissioner for Persons with Disabilities [CCPD], advertisement for appointment of a Chairperson of the RCI, the initiative for appointment of a Chairperson of the National Trust and the positive assurance by the Minister of Social Justice and Empowerment Mr. Thawarchand Gehlot that the Ministry will consult the Disability sector on the contents of the RPD Bill before finalizing it and passing it.

While appreciating these developments, the meeting felt that it was necessary to keep the pressure on so that there is no backtracking on the part of the Government and delaying passing of the long-awaited RPD Bill in the Budget session of the Parliament.

You are aware that at present the Bill is under review of the Group of Ministers [GoM] and they are yet to have another couple of meetings (the next one is scheduled for 15th Feb. 2016) before they finalize their recommendations and send them back to the cabinet.

The meeting therefore was of the view that since the Parliament is starting with the Budget session on 23rd February 2016, we should keep the pressure on and decided to have the rally on **Tuesday, the 23rd February 2016**. A separate circular giving the details of the programme is enclosed. Also attached the letter addressed to Hon'ble Minister of Social Justice and Empowerment Mr. Thawarchand Ghelot for your information.
